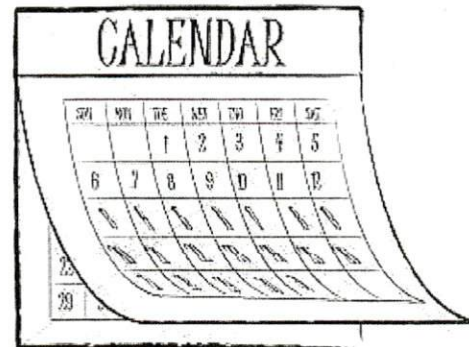

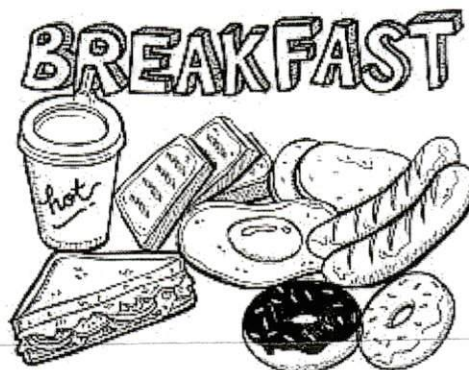

ANTIQUE ENGINE AND TRACTOR ASSOCIATION MEMBERSHIP MEETING MINUTES

April 13, 2019

President of the Board of Directors Phil Jordan thanked the Geneseo Moose Lodge staff for the wonderful breakfast they served. He then called upon Loren Book to provide a brief power point presentation on the history of the Moline Plow Company and the Moline Universal Tractor. President Phil Jordan called the Membership Meeting of the Antique Engine and Tractor Association to order at 9:15 a.m. at the Geneseo Moose Lodge, 1025 South State Street, Geneseo, Illinois 61254.

President Phil Jordan called upon Tom Hitzhusen to report on the Geneseo Foundation Grant of \$14,000 received for a project at the Blacksmith Shop to install a line shaft and a Cane Sugar Press. Tom also reported on the plans for the acres of crops for this year's fall working farm show and the donations of seed, chemicals and services worth about \$8,000.

President Phil Jordan lead a discussion in regards to the need for additional space at the AETA Show grounds for inside activities and security of the records and supplies which are currently stored at different locations including members of the board of directors and committee chairmen. The need for additional restrooms and space to display and secure rare and expensive equipment was noted. Following a lengthy discussion on the estimated cost of construction and the pros and cons of an addition to the existing barn verses a separate building and the issues of construction schedules, a motion was made by Mark Johnston and seconded by Larry Gay to investigate the detailed cost of a separate building and report back to the membership at a future date. Motion carried by a show of hands with a significant majority of those in attendance.

President Phil Jordan announced the schedule for membership work days at the AETA Show grounds, May 25th; June 29th; July 27th; and August 24th. The date for the AETA Tractor Drive is June 17th with a rain date of June 18th.

There being no further business to come before the meeting a motion was made by Ed Klundt and seconded by Skip Farnam to adjourn the meeting. Motion Carried.

ANTIQUE ENGINE AND TRACTOR ASSOCIATION MEMBERSHIP MEETING MINUTES

May 25, 2019

President of the Board of Directors Phil Jordan called the meeting to order and thanked the members for attending the May 25th membership meeting and work day at the Timber Frame Barn 13451 IL Hwy 92, Geneseo, Illinois 61254 at 8:00 a.m. Secretary Bob Delp recorded the actions of the meeting.

President Phil Jordan reviewed the history of looking at adding additional space at the AETA Show Grounds. A motion was made at the last membership meeting to investigate the cost of building a separate building at the show grounds (72' x 40' - 16' eves). He reported that the board put specifications together for a building and received estimates from several builders to construct a building, just as a shell as Phase I with Phase II to be completed later as we finish the insides with bathrooms, office space and conference room, and would also connect the new building to the existing Timber Frame Barn with a wall-way. Funding for such a project was discussed with Donations, Grants, Fund Raisers and Bank Loan where considered. A construction loan vs a Phase I and Phase II advance on the project was discussed with the local bank with a promising outcome.

President Phil Jordan had a question and answer session with the member participation followed with a motion from Roger Mixer seconded by Ed Mayhew to move forward with the project.

President Phil Jordan announced the schedule for membership work days at the AETA Show grounds, June 29th; July 27th; and August 24th. The date for the AETA Tractor Drive is June 17th with a rain date of June 18th.

There being no further business to come before the meeting, President Phil Jordan declared the meeting adjourned at 9:15 a.m.

Board Meeting

The AETA Board meeting was held June 10, 2019, at the AETA Timber Frame Barn 13451 IL. Hwy 92, Geneseo, Illinois 61254 at 6:30p.m.

President Phil Jordan called the meeting to order and Secretary Bob Delp recorded the action of the meeting.

The following directors were present, Phil Jordan (President), Chad Jacobs (Vice-President), Bob Delp (Secretary), Alex Samuelson, Al Swanson, Deb Jacobs, Leon Rathjen being all the directors except Jim Gradert (Treasurer) and Kyle Jahn.

Secretary Bob Delp had provided each of the directors with a copy of the minutes of the May 2019 Board Meeting. Following discussion, a motion was made by Alex Samuelson and seconded by Leon Rathjen to approve the minutes as presented. Motion carried.

Treasurer Jim Gradert provided each director with a copy of the May 2019 treasurer's report. Following discussion, a motion was made by Alex Samuelson and seconded by Chad Jacobs to accept the treasurer's report as presented. Motion carried.

President Phil Jordan presented information in regards to the proposals for the new building on the east side of the Timber Frame Barn. Following discussion, a motion was made by Leon Rathjen and seconded by Chad Jacobs to work with Bob Johnson Construction to build a Lester building. Motion carried.

President Phil Jordan reported on the items to be included in this year's goodie bags at the Fall Working Farm Show.

President Phil Jordan asked Al Swanson (Membership Chairman) to report on the status of paid memberships. He reported 108 life members and 230 paid memberships for a total of 338 members as of June 10, 2019.

President Phil Jordan made the committee reports and discussed the status of the farm operations. He also reported that the work had begun on rolling the boiler for the steam engine and that the engine could be returned by some time in September of this year. There would still need to have the State of Illinois inspections completed before we could use the train on steam power.

President Phil Jordan reported on the schedule for the AETA Tractor drive June 17th with a rain date of June 18th. Work days have been scheduled for June 29th, July 27th and August 24th at 8:00 a.m. on each day at the AETA Show grounds. The next AETA Board Meeting is scheduled for July 1, 2019, 6:30 at the Timber Frame Barn.

There being no further business to come before the meeting, President Phil Jordan declared the meeting adjourned at 8:25 p.m.
